### BOARD OF REGENTS

#### September 22, 2011

The Board of Regents met in session at 9:05 a.m., Thursday, September 22, 2011, in the

Louisiana Purchase Room, Claiborne Building, 1201 North Third Street, Baton Rouge,

Louisiana. Chairman Robert Levy called the meeting to order. Executive Assistant Carolyn

Blanchard called the roll and a quorum was established.

#### **PUBLIC COMMENTS:**

Chairman Levy noted that no written requests were received for public comments and

asked whether the audience had any comments at the time. There were none.

#### APPROVAL OF THE MINUTES OF AUGUST 24, 2011

On motion of Regent Rasberry, seconded by Regent Stokes, the Board voted unanimously to approve the minutes of August 24, 2011.

### <u>REPORTS AND RECOMMENDATIONS BY THE COMMISSIONER OF HIGHER</u> <u>EDUCATION</u>

Dr. Jim Purcell, Commissioner of Higher Education, presented opening remarks regarding education versus poverty. One article stated that one in six Americans are now officially poor as the poverty rate climbs to a 27-year high. According to current population reports, the South was the only region to show an increase in the poverty rate.

A publication entitled "Help Wanted – Projections of Jobs and Education Requirements through 2018" stated that "postsecondary education has become the gatekeeper to the middle class and the upper class." Dr. Purcell said when there is less education, there tends to be greater poverty. Data show that education is a path to the future. Ninety percent of college graduates were employed in 2010 compared to 64% of those who did not attend college but went straight to work after high school. He said analysts discovered that college graduates are making almost double the annual earnings of those with only a high school diploma. The more education you obtain, the better your job prospects and future earnings.

Data from the last ten years show more students are attending public higher education institutions. In Louisiana, eighty-six percent of students in postsecondary education are in a public institution.

Will Louisiana produce more graduates in the year ahead? Preliminary enrollment indicates that more students are beginning their higher education in community colleges.

Dr. Purcell reminded the audience of the three goals of the Master Plan: (1) increase the educational attainment of Louisiana's adult population to the Southern Regional Education Board states' average by 2025; (2) invest strategically in university research; and (3) achieve greater efficiency and accountability in the postsecondary education system.

#### EDUCATION ESTIMATING CONFERENCE BY MS. STAFFORD PALMIERI, GOVERNOR'S EDUCATION ADVISOR

Ms. Stafford Palmieri, Governor's Education Advisor, introduced background information regarding the Education Estimating Conference (EEC) created in the 1990's by RS 39:21.3(C). Ms. Palmieri is the Chair of EEC and said the Conference evaluates historical trends in student enrollment, teacher salaries, etc. and projects trends for budgeting purposes on the state and local level.

She discussed the forecast of total demand for Louisiana's public school regular program classroom teachers and special needs teachers as well as preliminary school district enrollment projections for academic years 2011-2012 through 2016-2017.

She said the Conference is comprised of six members. The EEC is undergoing a selfassessment to see how it can assist agencies in the state. Ms. Palmieri requested the members of the Board give feedback to her regarding numbers provided and whether they are useful to the Board.

A question and answer period followed. Ms. Roy inquired if there were a higher education representative on the EEC. Ms. Palmieri noted that at this time there is no statutorily appointed higher education representative, but that Mr. Todd Barré, Board of Regents, attends the meeting to represent higher education. She said the Conference would consider a higher education membership at its next meeting.

#### VALUE-ADDED RESULTS FOR TEACHER PREPARATION PROGRAMS BY DR. JEANNE BURNS, DR. GEORGE NOELL AND DR. KRISTIN GANSLE

Dr. Jeanne Burns of the Board of Regents and Dr. George Noell of the Louisiana State University and A&M College presented a PowerPoint entitled "Value-Added Teacher Preparation Assessment Model: 2010-2011 Results." Dr. Burns said that Louisiana is in a unique position of having two value-added models that can be used to examine the effectiveness of teacher preparation programs – (1) the Board of Regents' Value-Added Teacher Preparation Assessment model and the Louisiana Department of Education's (LDoE) Value-Added Teacher Evaluation model. A decision was made to use one consistent model to examine the effectiveness of teachers and teacher preparation programs in Louisiana. The model to be used will be the value-added teacher evaluation model developed for the Louisiana Department of Education.

Dr. Noell continued by explaining in detail the LDoE model and the rationale for using the Value-Added Teacher Evaluation model. He also spoke regarding the criteria for calculation and reporting on mean scores for teacher preparation programs.

Dr. Burns commented that teacher preparation programs that previously attained low value-added scores entered into Programmatic Intervention. Recently, three programs attained a value-added score at Performance Level 3 and exited Programmatic Intervention while one program remains in Programmatic Intervention. The next step will be for the Board of Regents to provide each campus with breakdown data for their value-added results.

# PROJECT UTILIZING ALTERNATIVE MEANS OF FINANCING

On motion of Regent Rasberry, seconded by Regent Gorman, the Board voted unanimously to accept the recommendation of the Facilities and Property Committee to approve the project to construct a parking garage at McNeese State University utilizing alternative means of financing. The terms of the lease-leaseback agreements with Cowboy Facilities, Inc. will provide approximately 900 parking spaces with debt amortization to come from a student self-assessed fee as approved in a student referendum. Other terms are as outlined in the accompanying documentation.

The latest edition of the Council for a Better Louisiana (CABL) Wire has framed many of the issues surrounding our colleges and universities. CABL has been a great supporter of higher education reform efforts including the GRAD Act. A message in the article states, "Over the last couple of years, thanks largely to budget cuts, there has been more focus on higher education in Louisiana than any time in recent years. The attention is good, but unfortunately the debate hasn't always been about the value of post-secondary education and what we need and expect for it to deliver to our state and its citizens..." This is the right message and this CABL Wire publication validates our efforts.
