You will find attached draft copies of the three syllabi for us to discuss during our conference call on Wednesday, May 28 from 1:00 to 4:00. These are still very much in draft form and need further development.

During our last conference call, we had some confusion about how to integrate the CDA Standards, Goals, and Functional Areas into the CDA Portfolio. Karri Kerns shared a document that was developed by the North Dakota CCR&R which discusses how to create a CDA Professional Resource File. I have attached the document provided by Karri. We used that document to identify a way in which we might subdivide the portfolio requirements into each of the three courses. We also slightly changed the wording of the first course to indicate that the course is also to introduce the candidates to the “CDA credentialing process.” Please examine the attached document provided by Karri and also examine the section of the syllabi called “Outcome, Evidence, and Criteria” in each of the attached syllabi. Again, more work needs to be done in this section for we have only listed the “artifacts.” However, please be prepared to discuss whether these are appropriate artifacts for each course.
