MINUTES BOARD OF REGENTS August 24, 2016

Prior to the Board's Committee meetings, Dr. Craig McClain, newly appointed Executive Director of the Louisiana Universities Marine Consortium, was introduced to the Board by Commissioner Joseph C. Rallo. Dr. McClain mentioned that his career as a marine biologist began during his undergraduate participation in a LUMCON summer course. He gave his vision for building and expanding LUMCON.

Dr. Adell Brown, Interim Chancellor of the Southern University Agricultural Center and Dr. William Richardson, Dean of the Louisiana State University Agricultural Center gave a joint presentation regarding the effective partnership between the two agricultural centers.

Senator Sharon Hewitt of District 1 addressed the Board regarding Act 619 of the 2016 Regular Legislative Session relative to postsecondary education. She said the Act requests the Board of Regents to conduct a comprehensive review of the present postsecondary education system in the state and recommend the optimal delivery of postsecondary education in the future that will meet the needs of the state's citizens and industries while maximizing the state's resources. The review shall be of the state as a whole and of its workforce development areas as provided in R.S. 23:2192. She continued by stating that the Board shall submit a written report detailing its findings and recommendations relative to the assets, needs, gaps, and barriers to creating a comprehensive, efficient, and cost-effective public postsecondary education system in Louisiana to the Senate and House committees on education by no later than fortyfive days before the 2017 Legislative Session.

The Board of Regents met in session at 11:45 a.m., Wednesday, August 24, 2016, in the

<u>GRAD Act Remediation Plan for SUBR and SULC and Improvement Plan for SU System and the GRAD Act Remediation Plan for BRCC and Improvement Plan for LCTC System</u> (*Information Item*)

Institutions failing GRAD Act can earn to up to 75% of lost performance funding upon approval of a remediation plan by the Commissioner of Higher Education and by entering into a GRAD Act Performance Improvement Contract. Following the failure of Baton Rouge Community College, Southern University and A&M College, and the Southern University Law Center for Year 6 of GRAD Act, Board of Regents' staff has been working closely with the LCTC System and SU System staff to develop remediation and improvement plans. Presentation of first quarterly reports from the Louisiana Community and Technical College System and Southern University System is currently scheduled for the October Board of Regents' meeting.

Elevate Louisiana: The New Reality for Higher Education

A. Guiding Principles for Proposed Mergers or Consolidations (Information Item)

Chair Adley suggested that this item be deferred until the September meeting to allow the

Board adequate time to review the document and provide feedback.

B. Financial Health Analysis

Approve (1) placing institutions with a fiscal score of 1.75 or below on fiscal watch immediately; and (2) requiring the respective management boards to submit a corrective action plan for each institution at the September 2016 Board of Regents' meeting.

C. Elevate Louisiana Timeline and Action Items (Information Item)

This item was informational only regarding the timeline and action items.

<u>REPORTS AND RECOMMENDATIONS BY THE COMMISSIONER OF HIGHER</u> <u>EDUCATION</u>

Commissioner Joseph Rallo said the staff has been busy during the summer with several

items as noted below.

- 1. Act 619 of the 2016 Regular Session, authored by Senator Hewitt, supports the Board of Regents' constitutional authority to conduct a comprehensive analysis of Louisiana public higher education. Specifically, this analysis will allow us to better plan for the future of higher education by prioritizing resources, improving academic offerings, stimulating innovative research, and responding to local/regional workforce needs. Senator Hewitt's bill also requests that recommendations be made in specific areas for the advancement of public higher education.
- 2. As a result of the 2016 Regular Session, the Louisiana Office of Student Financial Assistance (LOSFA) and Louisiana Universities Marine Consortium (LUMCON) are now under the oversight of the Board of Regents.
- 3. Act 172 of 2015 required the Board of Regents and the Attorney General to jointly prepare training materials for confidential advisors and other individuals who are involved in any sexual assault grievance procedure at every public postsecondary education institution. Institutions must make sure that confidential advisors and individuals involved in student grievance procedures complete the training before the beginning of the 2016-2017 academic year.
- 4. The first Formula Summit was held on Wednesday, August 3, 2016. This was an interactive, educational event designed to inform employees/stakeholders of the purpose and methodology of the Board of Regents' outcomes-based funding formula for two- and four-year institutions.
- 5. A faculty forum will be held on Friday, September 30, 2016 in Alexandria. The forum is designed to reengage faculty from across the state in discussions relative to the future of public post-secondary education. The agenda will be crafted around this year's theme *Elevate Louisiana! Higher Education and Workforce Preparation*.

Chair Lipsey thanked all Committee Chairs for their tireless work with Committee staff

during the legislative session and summer months regarding important higher education issues.

Regent Martin thanked Chair Lipsey for his leadership during this past year.

OTHER BUSINESS

Other business introduced by Regent Lipsey included:

- The next board meeting is scheduled for September 21 and 22, 2016. Budget hearings will be held on September 21 and Committee/Board meetings on September 22, 2016.
- The Board meeting in October has been postponed until November 2, 2016, and will be held in north Louisiana.
- An invitation was received from Superintendent of Education John White to the "*Every Student Succeeds Act (ESSA) Briefing for Higher Education.*" Louisiana is currently undergoing a review of its educational system to ensure that all students—regardless of their race or ethnicity, learning ability, economic status, or geographic location—have access to enriching, high-quality courses taught by exceptional teachers. This review will result in the development of a long-term state education plan that builds upon Louisiana's recent successes and adheres to the provisions of the new federal education law. Our mutual goal is to ensure all Louisiana students are on track to successfully transition to college or a career after high school graduation.

ADJOURNMENT

There being no further business to come before the Board, the meeting was adjourned at 12:55 p.m.
