Internal Audit Charter for Review

- ❖ An internal audit charter is required under the Institute of Internal Auditors (IIA) International Standards for the Professional Practice of Internal Auditing (*Standards*)
- ❖ Louisiana Revised Statute (R.S.) 17:3138.6 requires the establishment of an internal audit function that adheres to the IIA *Standards*
- ❖ Formal document that defines internal audit's purpose, authority, responsibility and position within the organization
- ❖ BOR internal audit charter requires annual review and approval (last reviewed and approved August 13, 2020)
- ❖ P&N has reviewed and does not recommend any updates or changes to the current internal audit charter

- The Regular Legislative Session concluded on June 10, 2021.
- \$108.5M State General Fund increase for higher education:
 - \$11.4M increase for FY21
 - \$97.1M increase for FY22
- This is the largest base increase to higher education since FY09.
- This is the most SGF base funding (excluding TOPS and GO Grants) since FY13.

AGENDA ITEM IV.

Alternatively Financed Project: Southern University and A&M College (SUBR) Honors Housing and New Student Union

- The Southern University Board of Supervisors submitted a request on behalf of SUBR to construct new honors housing and a new student union to enhance the overall student experience, support retention of students, and build a more engaging sense of community on the Baton Rouge campus.
- SUBR received a Historically Black Colleges and Universities loan to finance each project inclusive of all associated costs.
- The housing component consists of 300-350 suite style beds with a total project cost of \$37M.
- The new union will be approximately 90,000 square feet with a total project cost of \$43M.
- Debt service will be satisfied from the housing revenues generated and a proposed student/activity fee.
- SUBR intends to have both facilities open for the fall 2024 semester.



STAFF RECOMMENDATION

Senior Staff recommends approval of the alternatively financed project submitted by the Southern University Board of Supervisors, on behalf of Southern University and A&M College, to construct honors housing and a new student union.

ADMISSIONS AUDIT FOLLOW-UP TO FALL 2018

Prior Audit Results

Fall 2018 Results:

- All institutional submissions contained data errors in Statewide Student Profile System (SSPS). GSU, SUNO and UNO's submissions contained significant data errors such that auditors were unable to audit the admissions exception rate.
- Louisiana State University materially exceeded the allowable admission exceptions limit.

Scope and Objective

Scope: Performed a procedural follow-up review to the Fall 2018 Admissions Audit.

Objective: Determine whether recommendations were implemented, and previous audit issues have been corrected at SUNO, UNO, GSU and LSU.

ADMISSIONS AUDIT FOLLOW-UP TO FALL 2018

Methodology

- Due to restrictions and health concerns necessitated by COVID-19, audit did not perform physical campus site visits.
- Audit conducted meetings and interviews with university enrollment staff to discuss corrective actions implemented in response to the Fall 2018 admissions audit.
- Audit reviewed institutional policies and procedures and other documentation to determine if corrective actions had been procedurally implemented as well as to assess if the institution is adequately situated to comply with BoR *Minimum Admission Standards for First-Time Freshman*.
- While the objective of this review was not to test sample data, Audit also queried admissions data through SSPS to determine if clear errors identified had been corrected in subsequent years, when necessary.

Fall 2018 Findings: Substantially Remediated

- **Southern University at New Orleans** implemented procedural corrective actions such that the issues noted in the Fall 2018 report were substantially remediated.
- **University of New Orleans** implemented procedural corrective actions such that the issues noted in the Fall 2018 report were substantially remediated.

Current Audit Findings: Observations

Grambling State University

Inaccurate Reporting of High School and Regents' Core GPA

- GSU has not addressed the data inaccuracies in the High School and Regents' Core GPA fields which contributed to the errors noted in the Fall 2018 report.
- If left unresolved, the BoR will be unable to rely on GSU's data to conduct an exception rate audit in all subsequent years.

Current Audit Findings: GSU Observations

Recommendation: GSU must implement a procedure to capture the Regents' Core and High School GPAs and ensure all data is properly reported to the BoR in accordance with SSPS specifications.

Management's Response: GSU's President concurred with the observation and recommendation. Corrective actions will be implemented by the Fall 2021 semester.

Current Audit Findings: LSU Observation

Louisiana State University

Possible Noncompliance with Mandatory Admissions Policies

- LSU could not provide objective admissions criteria for Fall 2019 that would ensure incoming freshman would be admitted in accordance with BoR policies and not exceed the 4% exceptions allowance.
- LSU supplements the admissions process for students not meeting BoR admissions criteria with reviews of subjective, unmeasurable, non-cognitive variables. LSU personnel provided documentation of methods to focus on student success initiatives developed after the February 2020 BoR admissions criteria was implemented.

Current Audit Findings: LSU Observations

Recommendation: LSU must take action to ensure admissions practices comply with Board of Regents admissions policies.

Management's Response: LSU's President partially concurred with the recommendation. LSU's VP of Enrollment Management will be responsible for implementing corrective action. The solutions presented, which were completed in Fall 2020, may correct the underlying issue.

CHANGE TO ELIGIBILITY OF NON-STATE MATCH FOR ENDOWED PROFESSORSHIPS/FIRST-GENERATION SCHOLARSHIPS

Incremental contributions will be accepted provided the donor:

- Began contributions before the 2016 match rate change;
- Specified an intent for the contribution to be matched by BoRSF for a permanently Endowed Professorship/Scholarship; and
- Has completed the minimum contribution for matching prior to request.

All other provisions of the policy remain unchanged; eligible willed donations documented prior to the 2016 match rate change are already accepted.



STAFF RECOMMENDATION






