# Minutes Board of Regents' Advisory Commission on Proprietary Schools July 11, 2023

The Louisiana Board of Regents' Advisory Commission on Proprietary Schools met Tuesday, July 11, 2023, in Room 153 in the Claiborne Building. Chair James Fontenot called the meeting to order at 10:00 a.m. The roll was then called by Ms. Courtney Britton and a quorum was established. There were no public comments to be read.

The first item of business was the approval of minutes from the Commission's meeting on May 9, 2023.

On motion of Chris Broadwater, seconded by Carmen Million, the Advisory Commission on Proprietary Schools unanimously adopted the minutes of the May 9, 2023, Advisory Commission on Proprietary Schools meeting.

The next item considered by the Commission was an application for an Associate of Occupational Studies (AOS) degree in Game Design and Production from the Academy of Interactive Entertainment (AIE). AIE was originally licensed on September 22, 2010, and is accredited by the Council on Occupational Education. Head of School, Robin Couvillon, was present to present the AOS application to the Commission.

Discussion included the cost of the program, expected wages, financial aid available for students, student success and job placement rates.

On motion of Chris Broadwater, seconded by Carmen Million, the Advisory Commission on Proprietary Schools unanimously voted that the Board of Regents approve the Associate of Occupational Studies in Game Design and Production at the Academy of Interactive Entertainment, Lafayette, Louisiana.

The next item considered by the Commission was initial license applications. The only initial license application was from Clinical Lynks, located in Metairie, LA. The school was represented by the owner, Ms. Kwanza Gaines. Ms. Mighan Johnson reviewed the materials for the Commission members, informing them that the institution was proposing to offer one program: Phlebotomy Technician.

Discussion included Ms. Gaines' background and two decades of experience in the field of phlebotomy and her desire to train skilled phlebotomist in the area, as well as the financial stability of the school based on the provided financials, business plan, and the length of time Ms Gaines has been preparing to open her school. Further discussion included additional documents that need to be submitted to the Commission for demonstration of the owner's readiness to begin operation of the school. The requested items are an updated business plan, that includes a more detailed marketing plan and a pro forma statement, which includes financial projections for two years.

On motion of Chris Broadwater, seconded by Sherrie Despino, the Advisory Commission on Proprietary Schools unanimously voted to defer the initial license application for Clinical Lynks, to the next meeting of the Commission after review of the additional materials requested.

The next agenda item considered by the Commission was operating license renewals. Over the previous two months, 22 schools submitted complete renewal applications.

On motion of Sherrie Despino, seconded by Carmen Million, the Advisory Commission on Proprietary Schools unanimously voted that the Board of Regents renew the licenses of the following proprietary schools:

#### **Update on Early Childhood Initiatives**

#### **Background**

Nearly four million U.S. undergraduate students (22%) are raising children while attending a postsecondary education institution. More than half (53%) of student parents are raising a child under the age of six. Most student parents are mothers (70%) and over 43% of all student parents are single mothers. Most student parents are students of color (53%), with Black and Indigenous women in college being particularly likely to be parenting compared with other women and men in college. The largest share of student parents (42%) are enrolled at community colleges. Another 18% attend for-profit institutions, 17% public four-year institutions, 13% attend private non-profit institutions, and 10% attend other institution types or more than one institution (IWPR and Ascend at the Aspen Institute 2019).

Student parents often face many demands on their time. Most students work 25 hours or more a week and are enrolled full time. Students with children also face higher non-tuition costs than their peers without children. They spend more on food, clothing, personal care, utilities, housing, and transportation than their childless peers.

Securing affordable and reliable child care is important for student parents to enroll in college and to remain enrolled (Contreras-Mendez and Rechlin Cruse, 2021). On average, families pay approximately \$10,000 annually for center-based care. The challenge that student parents face regarding child care access during college entry and completion can make it more difficult for them to successfully graduate compared to students who are not parents.

#### **Understanding Campus-Based Child Care Services**

Understanding the importance of quality early childhood programming plays a critical role in a students' ability to complete college. Campus Early Learning Centers are unique and play a pivotal role in student success, however many families with young children struggle to access information, resources, programs, and services for young children. In Louisiana alone, nine out of 10 children under the age three are from economically marginalized households that lack access to affordable child care. Research shows that 80% of a child's brain architecture is developed by the time they turn three years old. This developmental period forms a foundation for all future behavior, learning, and health. It also represents the period when many parents are learning to parent for the first time. Quality early childhood programs are the key to our economic future. Knowing this, the campus early learning center collaborative was formed. This collaborative provides campus early learning center staff skills on business development, enrollment, family supports, grant writing, and early childhood capacity building on campus. Initiatives, such as consulting with each campus on the competitive federal grant program called Child Care Access Means Parents in School (CCAMPIS), are being undertaken. This grant if awarded will provide campus-based child care services to support low-income parents in post-secondary education.
