This university is accredited by the Middle States Commission on Higher Education (MSCHE) and the Association for Advancing Quality in Educator Preparation.

#### ACADEMIC PROGRAM

TC offers the Summer Principals Academy (TC-SPA) that allows students to earn either a Master of Arts (M.A.) or Master of Education (M.Ed.). The course work and content are the same for the program, but there are two master's degrees that can be acquired at the completion of this program. The Master of Arts (M.A.) is a 36-credit program and the Master of Education (M.Ed.) is 36 credits plus 24 transfer credits from a previous graduate degree. This allows students who have previous graduate credit to use this along with the course work provided at the SPA to earn their master's degree. The university currently has 65 students enrolled in this program according to the Louisiana Unduplicated Headcount Enrollment.

The next agenda item explained reports on the Fiscal Year 22-23. After Ms. Britton presented the numerical summary of the fiscal year, Ms. Deesi Kirkland presented the fiscal year 2022-2023 financial updates. Discussion including the consistency of the carryovers of revenues (self-generated), expenditures; specifically the retirement contributions and the contributing factors, Student Protection Fund-Student Record Administration Account; specifically the difference between the protection and records maintenance accounts, the amount currently in the student protection fund, the consistency of the expenditures on the account since last year, potentially dropping another rental unit for student record housing, suggestions for breakdowns for the next year including a ten-year analysis.

The next agenda item was voting on the upcoming meetings and hearings. Discussion included the possibility of Commission members receiving additional evidentiary items prior to any upcoming hearing dates, the number of open applications for January and timing of due dates and meeting dates in regard to state holidays.

On motion of Carmen Million seconded by Benjamin Baudin, the Proprietary Schools Advisory

Commission unanimously voted to conduct the administrative hearing at the next commission meeting scheduled for January 16, 2024.

The next agenda item was other business. Discussion included Advanced Welding school closure, and student reimbursement, school bonds, student-level data submission and violations, discussion with potential applicant guests including auditing the financials yearly and staff assistance with applications, common questions commission members ask, and mistakes potential applicants make.

The next meeting of the Proprietary Schools Advisory Commission is scheduled for January 16, 2024, at 10:00 a.m., in Room 1-153 of the Claiborne Building. There being no further business, the meeting adjourned at 11:00 a.m.

#### **Approval of Payment from Student Protection Fund**

### Advanced Welding School Walker, Louisiana

Advanced Welding School, a former Louisiana licensed proprietary school, which was located at 10340 Florida Blvd, Walker, LA 70785, officially closed on November 30, 2022. As the closure was unplanned, students were left behind in various states of program completion. Staff contacted twenty-nine students who the school identified as enrolled at the time of closure, while the majority of the students chose to continue their education at other postsecondary institutions or to find employment in their field with the education they received, there were some students who could not complete their studies.

For those students who could not complete their studies, the Louisiana Proprietary Schools Law allows them, or a payee on their behalf, to be reimbursed for tuition payments. La. R.S. 3140.11. A. states: "There shall be established in the state treasury as a special permanent account the Proprietary School Student Protection Dedicated Fund Account. Following compliance with the requirements of Article VII, Section 9 (B) of the Constitution of Louisiana relative to the Bond Security and Redemption Fund, all monies generated pursuant to the provisions of this Section shall be deposited into the Proprietary School Student Protection Dedicated Fund Account, and monies in this account shall be used solely to make refunds of unearned tuition as provided in this Chapter." In addition, La. R.S. 3140.11. I. states that a "claim shall be made against the account only if it arises out of the cessation of operation and after claims are made against the surety bond or other school financial resources." As such, a \$10,000 dollar claim has been made against the school's surety bond to the Western Surety Company. This amount will be deposited in the Student Protection Fund and will be utilized in making any necessary reimbursements to students.

Per law, any claims were required to be submitted within twelve months of the school's closure. A total of six students completed the Student Claim Form (PSC-15) and submitted accompany documentation such as enrollment agreements, transcripts, receipts, applicable affidavits and any required W-9s. The total amount requested for these students is \$127,821.84, however final reviews performed by staff from Proprietary Schools, Finance and Legal may adjust the amount owed. The current balance in the Student Protection Fund is \$1,123,211.20.

#### STAFF RECOMMENDATION

Given the final review of claims by Board of Regents staff and Louisiana Proprietary School Law requirements, Senior Staff recommends approval of tuition reimbursement payments to students from the closed proprietary school, Advanced Welding School.
