Minutes Board of Regents' Proprietary Schools Advisory Commission March 12, 2024

The Louisiana Board of Regents' Proprietary Schools Advisory Commission met Tuesday, March 12, 2024, in

Room 155 in the Claiborne Building. Chair James Fontenot called the meeting to order at 10:00 a.m. The roll was then

called by Ms. Courtney Britton and a quorum was established. There were no public comments to be read.

The first item considered by the Commission was the approval of minutes from the Commission's meeting on

January 31, 2024.

On motion of Ms. Sherrie Despino, seconded by Ms. Melanie Amrhein, the Proprietary Schools Advisory Commission unanimously adopted the minutes of the January 31, 2024 Proprietary Schools Advisory Commission meeting.

The next item on the agenda was initial applications for licensure. The first initial license application was from

Royal Angels Anointed Hands, located in Greensburg, LA. Ms. Mighan Johnson presented the application materials to the

Commission. The school was proposing one CNA program at 84 clock hours/2 weeks. This application was deferred by

the Commission from their January meeting after more materials were requested from the school owner. The school

owner, Shameka Royal, represented the school. Discussion included acknowledgment of the \$50,000 letter for line of

credit and other additional items provided by the owner, length of time and number of graduates when the school was previously opened, the benefits the owner found in completing a more in-depth business plan, and the capitalized equipment noted on the balance sheet.

On motion of Ms. Amrhein, seconded by Ms. Despino, the Proprietary Schools Advisory Commission unanimously voted that the Board of Regents approve the initial license application for Royal Angels Anointed Hands, Greensburg, Louisiana.

The second initial license application was from Persistent Medical Education, located in Breaux Bridge, LA. Ms. Johnson presented the application materials to the Commission. The school was proposing a Nurse Aide Training program of 84 clock hours and 4 weeks. The school owner, Casey Broussard, represented the school. Discussion included the owner's 20 years as a nurse and the inspiration to start the school to serve the local parish and help the community, the program serving as an entry point to the medical field for students, the continuing education component, the solicitation of students, the school's business model and plans for continuing education courses for those already in the medical field, the instructional staff, and the timing of the classes offered.

On motion of Ms. Amrhein, seconded by Mr. Ben Baudoin, the Proprietary Schools Advisory Commission unanimously voted that the Board of Regents approve the initial license application for Persistent Medical Education, Breaux Bridge, Louisiana.

The third initial license application was from Premier Diagnostic Institute, located in Metairie, LA. Ms. Johnson presented the application materials to the Commission. The school was proposing a Cardiovascular Ultrasound program of 1800 clock hours and 45 weeks. School owners, Holly Leger and Kasey Duncan, represented the school. Discussion included the owners 16 plus years in the field of cardiovascular technology, the importance and critical need for better trained sonographers with the high rate of cardiovascular issues in South Louisiana, the high number of open positions in the field across the state, the difference between other ultrasound programs and cardiovascular ultrasound, requirements for entry into the program, and the support the school will receive from physicians on staff, the financial support the school can receive from the owners' current business, the tuition cost and loan opportunities for students, and how students will be eligible for the national registry upon completion of the program.

On motion of Ms. Despino, seconded by Ms. Amrhein, the Proprietary Schools Advisory Commission unanimously voted that the Board of Regents approve the initial license application for Premier Diagnostic Institute, Metairie, Louisiana. The next agenda item considered by the Commission was the Change of Ownership application for Phlebotomy Training Specialist. Ms. Johnson presented the application materials. Phlebotomy Training Specialist was originally licensed in 2021. The school was proposing a Phlebotomy Training program of 40 clock hours and two weeks. Monica Sanborn and Dennis Cariello represented the school. Staff explained that the application was being presented even though it was incomplete due to the time limit on operations after the non-transferable license had expired and as well as the options available to the Commission when considering the application.

Discussion included the reason the application was incomplete, the date the new owners purchased part of the privately owned company and the reasons for the sale, that the original owners were still involved, that the school had locations in other states, the confusion of the audit requirement, the engagement letter for an audit of the submitted unaudited balance sheet, and other financial statements submitted to staff.

On motion of Mr. Randy Plaisance, seconded by Mr. Baudoin, the Proprietary Schools Advisory Commission unanimously voted that the Board of Regents approve the change of ownership application for Phlebotomy Training Specialist, Baton Rouge, LA on the condition that the completed audited balance sheet is delivered prior to the next scheduled Board meeting.

The next agenda item considered by the Commission was operating license renewals. Over the previous two

months, 17 schools submitted complete renewal applications.

On motion of Ms. Despino, seconded by Ms. Amrhein, the Proprietary Schools Advisory Commission unanimously voted that the Board of Regents renew the licenses of the following proprietary schools:
