2025 Legislative Priorities

Career Office Reform

Creates the Career Alignment Task Force with the charge to develop an institutional scorecard based on identified best and promising practices such as early-onset career advising (freshman year) and increased work-based learning opportunities, to connect students to employment opportunities and address outmigration.

TOPS for DOCS

Allows a TOPS-eligible student who previously opted out of TOPS to receive TOPS if returning to attend an in-state medical school. This is specifically designed to address Louisiana's physician shortage.

HB 275, Rep. Berault

Financial Aid Alignment

Align TOPS Tech Early Start, TOPS Tech and M.J. Foster scholarship eligibility based on critical-need programs identified by the Louisiana Workforce Commission.

HB 161, Rep. Hughes

2025 Legislative Priorities

Geaux Teach

HB 109, Rep. Thompson

Makes this existing program for future educators a first-restricted-dollar scholarship to provide tuition, books, and instructional materials for students in teacher prep programs.

TOPS Tech Early College Credit

HB 70, Rep. Brass

Expands eligibility criteria for a TOPS Tech award to include the attainment of early college credit in high school through completion of dual enrollment courses or other approved skills and learning measures.

Retirement

HB 24, Rep. Bacala

Relative to the optional retirement plan (ORP) administered by the Teachers' Retirement System of Louisiana (TRS), includes provisions for: expanding ORP participation; allowing employees with 7+ years of service to move from ORP to TRS; permitting employees over 60 to opt out of TRS; increasing the employer contribution rate to align with other Southern states; and creating an ORP Advisory Committee to inform the TRS Board.

2025 Legislative Priorities

Job Order Contracting

HB 566, Rep. Turner

Establishes job order contracting as an alternative project delivery method applicable to deferred maintenance of public facilities by postsecondary educational institutions for certain work types.

Healthcare Task Force Consolidation

HB 544, Rep. Turner

Creates a committee/subcommittee structure for the Health Works Commission, Nursing Supply and Demand Council, and Simulation Medical Training and Education Council.

HBCU Advisory Council

HB 142, Rep. Mena

Creates additional membership on Council and provides for student member travel payments, and examination of campus safety on HBCU Campuses.

Dual Enrollment Task Force

HB 71, Rep. Brass

Revises the membership of the Dual Enrollment Task Force by removal of two obsolete members and addition of two new members.

BOR Involvement or Implementation

Constitutional Convention

HB 586, Rep. McMakin

Convenes a constitutional convention for Tuesday, December 2, 2025, and names the Commissioner of Higher Education as a delegate.

Louisiana Transparency Act

SB 229, Sen. Miguez

Requires a series of reporting requirements for state agencies, individuals acting on behalf of foreign governments, and institutions receiving foreign donations.

NIL Task Force

HR 15, Rep. Young

Creates a task force to study issues relative to the name, image, and likeness of student athletes in Louisiana to be staffed by the Board of Regents.

UNO Transfer

SB 202, Sen. Harris

Transfers the University of New Orleans from the University of Louisiana System to the Louisiana State University System.

Hazing Training

HB 279, Rep. Boyd

Requires certain postsecondary education students to complete an anti-hazing course.

TOPS Excellence/Equalization

HB 77, Turner

Revises Taylor Opportunity Program for Students (TOPS) award amounts and adds an award category for students with an ACT score of 31 or above.

Bills of Interest

Support Fund

HB 579, Rep. Emerson

Transfers funds from the Louisiana Education Quality Trust Fund (LEQTF) and retains the Louisiana Quality Education Support Fund subject to legislative appropriation.

UAL/TRSL

HB 473, Rep. Emerson

Repeals certain funds in the state treasury and applies the monies from those funds to the Unfunded Accrued Liability (UAL) of the Teachers' Retirement System of Louisiana (TRSL).

Constitutional Funding Changes

HB 472, Rep. Emerson

Revises Article VII of the Constitution of Louisiana relative to revenue and finance.

LCTCS Bonds

SB 72, Sen. Reese

Relative to the issuance of bonds for financing certain capital improvement projects within the Louisiana Community and Technical College System.

Deferred Maintenance

HB 335, Rep. Turner

Requires the treasurer to deposit \$100M from the State General Fund (Direct) to the College and University Deferred Maintenance and Capital Improvement Fund.

DEI in State Agencies

HB 421, Rep. Chenevert

Requires state agencies to abolish all DEI programs, offices, and positions and all DEI performance requirements for employees, including higher education campuses and systems.

State Services and Benefits

SB 100, Sen. Miguez

Requires each agency defined in proposed law to determine the eligibility of individuals receiving state services and benefits from the agency, including determining which individuals attempting to receive state services and benefits are "illegal aliens" or "unaccompanied alien children."

ICE Reporting

HB 307, Rep. Henry

Requires a state agency or political subdivision to report individuals who seek public assistance and are not citizens of the U.S. to U.S. Immigration and Customs Enforcement (ICE).

Staff Recommendation

Consistent with the August 2011 policy, the Senior Staff recommends approval of LSU A&M's request to divide the Gordon A. and Mary Cain Chair in Chemical Engineering #2 into three (3) endowed professorships, as follows:

- (1) Gordon A. and Mary Cain Professorship in Chemical Engineering #6, with a corpus of \$1,000,000 (\$600,000 non-state/\$400,000 BoRSF);**
- (2) Gordon A. and Mary Cain Professorship in Chemical Engineering #7, with a corpus of \$500,000 (\$300,000 non-state/\$200,000 BoRSF); and**
- (3) Gordon A. and Mary Cain Professorship in Chemical Engineering #8, with a corpus of \$500,000 (\$300,000 non-state/\$200,000 BoRSF).**

BoRSF Award Types

Grants (68% of funds expended since 1987):

Matching funds to establish restricted permanent accounts that generate income for designated activities (student scholarships, faculty work – Chairs and Professorships) as defined by donors/campus/BOR



BoRSF Competitive Process

1. Requests for Proposals publicly released: guidelines for submission, criteria for review, and scoring rubrics
2. Q&A Period: Webinar, Campus/PI sessions, individual questions
3. Proposal Submission
4. External Reviews: All out-of-state readers with relevant expertise and no conflicts of interest
5. Consultant reports: Assessment of proposals and funding recommendations
6. **Report publication/Board action**
7. Contracting (successful projects) and debriefing (unsuccessful projects)

Competitive Awards

Criteria for Evaluation

- Criteria and scoring are published in RFPs and available to applicants during proposal development, as are copies of successful proposals.
- **General Measures:**
 - Project quality
 - Need/enhancement of capabilities
 - Impact (non-monetary “return on investment”)
 - Alignment with State/campus priorities
 - Potential for success/risk-to-reward ratio
 - Addressing program goals and requirements
- Each program defines and weights general measures differently based on program goals and objectives.
 - External evaluators use published criteria for assessment/debriefing



Non-Competitive Awards

- Endowed Professorships, Endowed First-Generation Undergraduate Scholarships
- Each BoRSF-eligible campus (42) guaranteed specified number of matches (2) per year
- Application materials (due March 31): affidavits and assurances that non-state match is eligible and on deposit, program guidelines will be followed, and donors understand BOR requirements and match obligations
- Same constitutionally mandated standards of all BoRSF programs (e.g., must support academic, research or agricultural programs; must be supplementary and enhancing; may not be used for operating costs)





A. Approval of Final Rulemaking – Chafee ETV*

Awards to implement provisions of the Consolidated Appropriations Act of 2021, which provide that the Chafee ETV shall be awarded without regard to financial need.

* The Chafee Educational and Training Voucher (ETV) Program awards \$5,000 per academic year to qualified undergraduate and graduate students who have been in the foster care system to assist in offsetting the costs of postsecondary education.

In order to be eligible, a student must be in the foster care system; have aged out of the foster care system or have exited the foster care system through legal guardianship or adoption after attaining the age of 16; or have been in the foster care system after the age of 14 and exited for reasons other than adoption, guardianship, or aging out.

LOSFA administers this program through a Memorandum of Understanding with the Department of Children and Family Services.










Act 751 Update

- Act 751 of the 2024 Regular Legislative Session created the College and University Deferred Maintenance and Capital Improvement Program to address the \$2B backlog in deferred maintenance facing our public higher education institutions.
- \$75M was appropriated in 2024 to initiate the program.
- Funding will be provided over a ten-year period.
- Allowable projects include the complete renovation of buildings with significant deferred maintenance needs, utility infrastructure, drainage, street, sidewalk and site infrastructure, mechanical/electrical/plumbing, roof repairs and replacements, and building demolition.
- New construction or additions to existing facilities are not permissible.





Total Act 751 Funded Projects By Type






LSU Act 751 Funded Projects By Type




SUS Act 751 Funded Projects By Type





The Graduate Transcript Graph




