## 3<sup>rd</sup> Party Project: ULM Student Hub & Dining Facility

- The University of Louisiana – Monroe (ULM), working with the University of Louisiana at Monroe Facilities, Inc. (ULMFI), intend to construct a new, 23,000 SF student hub and dining facility on the former site of Garret Hall (northwest corner of University Avenue and Northeast Drive).
- Project cost estimated to be \$12.2M with ULM contributing approximately \$5.5M and Aramark providing \$6.7M towards the development and construction of the facility. ULM's portion of the project will be financed through the issuance of tax-exempt revenue bonds secured by revenues collected by ULM from the Facilities Enhancement Fee currently assessed to student.
- Project structured as lease/lease-back agreement whereby ULM will lease the property to ULMFI for the purpose of constructing the facility then ULM will lease-back the completed facility from ULMFI with an option to purchase.
- The facility will house vendors such as Chick-Fil-A, Starbucks, a market, and other Aramark dining options.

# 2018-19 VACANCY REPORT SUMMARY FINDINGS

- **Overall Vacancies:**
  - Endowed Chairs: 19% (59 of 309)
  - Endowed Professorships: 9% (227 of 2,494)
- **Long-Term (>2 Years) Vacancy Rates:**
  - Endowed Chairs: 8% (24 of 309), down from 12% in 2017-18
  - Endowed Professorships: 3% (68 of 2,494), down from 6% in 2017-18
- **Campuses Over 20% Long-Term Vacancy Threshold:**
  - Endowed Chairs: 4
  - Endowed Professorships: 3



# RECOMMENDATION

- 2004 – Regents forms a Steering Committee and commissions a technical feasibility study
- Later in 2004 – Governor Blanco funds LONI Network with a \$40M pledge over the next 10 years
- 2005 – Regents establishes the LMC, hires first LONI staff, and State releases first bid for fiber network for the 1<sup>st</sup> generation platform for network services,
- 2006 – Regents utilizes Post-Katrina monies to purchase 1<sup>st</sup> generation instrument for HPC
- 2006 – Executes agreement with LSU for LONI Operations
- 2014 – Regents upgrades to the 2<sup>nd</sup> generation instrument for HPC
- 2016 – Regents upgrades to the 2<sup>nd</sup> generation platform for network services
- 2017 – Regents approved changing the “I” from Initiative to Infrastructure and we transitioned from a fee-based to subscription formula for cost reimbursement from institutions
- Current Activities
  - Deploying our 3<sup>rd</sup> generation instrument for HPC
  - Planning our 3<sup>rd</sup> generation platform for network services

  - \$17 million spent over the past 15 years with commercial vendors on instrument for HPC
  - \$17 million spent over the past 15 years with commercial vendors on network platform
  - \$5 million spent over the past 15 years with commercial vendors for other general products and services
  - \$193 million in economic impact to the State of Louisiana



#### Overall Experience with services received from LONI



## Minimum Standards for Admission Policy Summary of January 2020 Proposed Changes

- Outlined expectations that public institutions adhere to Board policy: Statewide First-Time Freshman Minimum Admissions Standards and Exception Allowances.
- Exception reporting based on a two-year rolling average.
- Supplemental 100 non-resident exceptions allotted.
- Institutions exceeding 1% of exception allowances flagged for review.
- BoR may apply graduated penalties in accordance with violations.



## *Demand for Legal Education is Declining in Louisiana*





Population per Number of Institutions Awarding Law Degrees



Population per Number of Law Degrees Awarded



Per 1,000 Population Age 25+, 2012-17



Percent of Population Age 25-64 with a Graduate or Professional Degree, 2013-17



2012-17, African-American compared to Total



## *The Shreveport Region is not Well Served by the Current Configuration of Law Schools in Louisiana*





- Create a New Branch of SULC in Shreveport
- Physically Relocate the Entire SULC Operation to Shreveport
- Create Incentives for Individual Lawyers to Re-Locate to Shreveport





## *Costs for Creating a Branch of SULC*

- Estimated Annual Operating Costs: \$4.5 to 5.5 Million
- Estimated Capital Requirements for 31,500 Gross Square Feet: \$14,700,000





## *Accreditation Issues*


- Relevant accreditors are the Southern Association Commission on Colleges (SACSCOC) and the American Bar Association (ABA)
- Both SULC scenarios would be “Substantive Changes” so would require review
- Both would require staff review and a plan, possibly a site visit
- Both would require all changes to be in place ***before*** approval

## *Conclusions and Recommendations*

- No compelling evidence that a new law school is needed in Shreveport
  - Louisiana does not have a legal education capacity problem
  - Louisiana has a distribution problem
- BOR should explore a range of alternatives to incentivize new law graduates to locate in Shreveport
- BOR should undertake a broader needs assessment study of the Shreveport/Bossier region looking at education/training needs in a wide range of fields



# RECOMMENDATION

**Senior Staff recommends the Planning, Research & Performance Committee receive the report and affirm two key recommendations:**



## RECOMMENDATION (CONTINUED)

- (1) No new law school be established in the Shreveport/ Bossier region.**
- (2) A comprehensive study of graduate program needs in the region be undertaken, and this academic analysis should assess workforce demand and community interest as well as higher education offerings in the area.**



## RECOMMENDATION (CONTINUED)

**The report and these recommendations should be shared with the Southern University, LSU and UL Systems as well as the Caddo Commission for evaluation, comment and active participation in the regional graduate program needs analysis.**




